**REGISTRATION NUMBERS:** Kittens, Cats, Alters and Household Pets must be registered with ACFA in order to be eligible for scoring for end of the year awards. That number must be present in the master catalog. If you do not have an ACFA registration number, Cats and Alters must pay a \$5 per day listing fee. Kittens and Household Pets are exempt. However, all **Bengals, Korats, Pixie Bobs, Singapuras, and NBC entries must have a registration number**.

**ENTRY FEES:** Entry fees must be included with the entry. No monies shall be refunded once received. Per show rules, once the entry is made you are responsible for the fees, even if you don't attend the show. Any overpayment shall be treated as a donation. There will be a **\$35 charge on all returned checks**. All entries must be typed or printed. Collect phone calls will be made in the event of any questions regarding the entry.

**BENCHING REQUESTS:** Ends of rows are reserved for the handicapped, clerks, and show committee. Your request will be honored as best we can. Please, no negative benching requests!

**HEALTH:** The club strongly advises that all cats and kittens be immunized against Feline Enteritis, Calici Virus, Rhino and Panleukemia at least 3 weeks prior to the show. Any entry from a cattery or house where there has been any infectious or contagious illness within 21 days prior to the show will be prohibited. All claws must be clipped or it will be done by a member of the club for a fee of \$5.00 per cat.

\*\*\*All cats in the show hall must be free of fleas, ear mites, fungus, and show no sign of contagious disease, illness or neglect.

**SUPPLIES:** The club will provide litter. Bring your own food and water dishes and litter pans. Single cages (included with entry fee) are 22x22x22. Double cages are 22x22x44. Please bring your own cage curtains. Sales cages are available only to exhibitors. No cat or kitten may be sold for less than \$125. 00 at this show since the club supports serious breeders. No kitten under the age of four months on the day of the show will be allowed in the show hall. No sales are permitted from carriers under the table. Must have a health certificate on all cats or kittens for sale.

**AWARDS:** Cats must be present to receive final wins unless excused by the show manager in writing prior to the closing time of the show.

**HOUSEHOLD PETS:** Will be judged in all 8 rings. HHPS must be altered if 8 months of age or older. HHPS must be immunized at least 3 weeks prior to the show. All claws must be clipped.

**TRANSFERS:** If your cat or alter is an <u>OPEN</u> in AM and receives 4 winners ribbons, you must claim the championship before the PM judging starts with the Master Clerk, before leaving the show hall, in order to be able to show your cat in PM Session. This applies to cats paying listing fees as well. Household Pets do not have their titles transferred as they must be claimed through Central Office.
