## Entries

Entries may be sent on official CFA entry forms by regular mail, email, or fax. All fees must accompany entries. **For email and fax entries, fees must be sent within 10 days of the entry** to insure confirmation of entry. Make checks payable to **Cat Fanciers of Washington**, or send PayPal entries to [meloncali@comcast.net](mailto:meloncali@comcast.net). **Fax/Email entries MUST be PAID within 10 DAYS of entry.** There are no additional fees for using email, fax, or PayPal. The fee for returned checks is \$75. **WAIVE SIGNATURE** on overnight entries.

## Show Hall

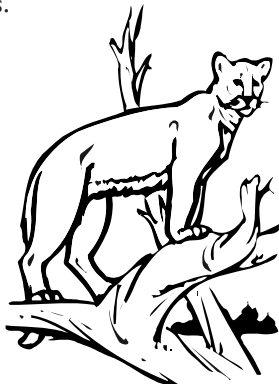
The show will be held in the spacious Sportsplex Indoor Sports and Event Center, 221 Commonwealth Ct., Winchester, Va. 22602 (540-868-2200). The building is heated and air conditioned and handicap accessible. No smoking is allowed in the show hall. Directions will be sent with confirmation.

## Benching / Show Hours

Check-in is from 7:30-8:30 am Saturday morning. Judging begins at 9:00 am. Advertised show hours are 9:00 am to 5:00 pm.

## Awards

## Cages / Supplies / Food

Cages are approximately 24"x24"x24". New exhibitors should bring fabric and clips for the floor, sides, and tops of cages. Litter will be provided; bring your own litter pan. People food will be available. **NO OUTSIDE FOOD IS ALLOWED IN THIS FACILITY.**

## General Information

All entries are expected to be free of fleas, fungus, and infectious illnesses. Cats and kittens should be inoculated for feline enteritis, rhino, and calici viruses and tested negative for FeLV before entry. All claws must be clipped. Declawed cats are not eligible to compete. No kitten under 4 months old will be allowed in the show hall. CFA show rules will be strictly enforced. A copy of the Show Rules may be obtained for \$5.00 from CFA, P.O.
