Please advise show manager by 2/2/09 of any medical reason you need special benching so we can accommodate you.

Other Information:

Any cat showing signs of fleas, fungus, ear mites, or kitten/s for sale without blue slip proof of age WILL be removed from show hall upon complaint. **NJ law requires rabies certificates for all cats.** They should also be inoculated against feline rhinotracheitis, calici viruses and rabies and tested for FeLV before entry.

All claws MUST be clipped prior to benching. **NO DECLAWED CATS ALLOWED.**

All Championship, Premiership and registered Kitten entries will be scored for CFA Nat'l and Reg'l awards. No vet inspection prior to benching. Cages approx. 22" x 22" x 22". No smoking in building. No litter pans provided, only litter. Bring your cat a water dish, food and coverings for cage tops, sides and floor. Cats may not remain in show hall after show hours. All entries must remain in hall until closing time (unless Kitten or HHP or permission received from Show Mgr. Show management is not liable for loss, damage or injury to cat or person at show, or for articles left behind after show. Show held under rules of CFA. A copy of the rules are available for \$5 from CFA, PO Box 1005, Manasquan NJ 08736 or on CFA web site. Entries must be on official CFA entry blank.
