**Show Hall** — Seguin- Guadalupe County Coliseum, 950 S. Austin St. is a handicapped accessible facility that is air-conditioned and heated. There will be a concession stand available for lunch. No outside food or beverages are allowed. **DIRECTIONS: Traveling on I-10:** Take Exit 609 (TX-123 BUS/Austin St.), turn South onto N. Guadalupe St. Turn right onto S. Austin St. and the coliseum will be on the right. **Traveling on I-35 from the North:** Exit 204A (TX-123/TX-82) in San Marcos, stay on frontage road approx. .2 mile and turn South on TX-123. Take TX-123 BUS (Austin St.) to coliseum on right. **Alternate route from Austin via TX-130 Toll Rd:** Take TX-130 (toll road) south to US 90. Toll approximately \$7.40 with TxTag or \$9.85 Pay By Mail. Turn West on US 90 (E. Kingsbury St.) to TX-123 BUS/N. Austin St. Turn south and continue to coliseum on right.

**Benching** — This is a non-vetted show. All entries should be vaccinated by a licensed veterinarian against feline panleukopenia, feline rhinotracheitis, calici virus and rabies, and be tested for feline leukemia before entry. Cats must be free of fleas, ear mites, fungus and any contagious illness. All claws must be clipped. Declawed cats are not eligible for entry. All entries are expected to remain in the show hall until the advertised closing time. Early departure without permission of show management will result in wins being voided. Kittens are exempt from this rule.

**Supplies** — Litter will be provided. Bring your own litter pans, cat food, and dishes..

**Household Pets** — Region 3 welcomes owners and their household pets. HHPs will be judged in all rings. Cats over 8 months of age are required to be neutered or spayed, but cannot be declawed.

**Awards and Scoring** — Championship, premiership, registered kitten, and household pets will be scored for CFA national and regional awards. Permanent flats will be used with ribbons on request. This show is licensed by The Cat Fanciers' Association, Inc., and its show rules will be strictly enforced. A copy of CFA show rules can be obtained for \$7.00 from CFA at 260 E Main St., Alliance Ohio, 44601 or online at [www.cfa.org](http://www.cfa.org). All championship, premiership, provisional breed, miscellaneous, HHP and AOV entries must be entered with a CFA registration number.

**Entries** — All fees must accompany the entry. A copy of the Show Catalog is included with the first entry. No entry fee will be refunded for failure to bench. There will be a \$50.00 service charge for returned checks. Please inform the entry clerk if you are bringing your own cage(s). **NOTE:** Exhibitors with security cages MUST pay for the double cage space and are requested to signify as such on the entry form. For those exhibitors using the cages provided by the Region, please bring cage curtains sufficient to cover the sides, back and top of the cage; approximately 22"X22"X22" single and 22"X44"X22" double.

**Liability** — Alamo City Cat Club, Gulf Shore Region, and Seguin-Guadalupe County Coliseum will **NOT** be liable for any loss or damage of personal property. Animals may **NOT** be left overnight in the show hall.

**Show Hotel** — La Quinta Inn & Suites, 1501 TX Hwy 46, Seguin, TX (830-372-0567) includes continental breakfast buffet each morning and free Wi-Fi. No pet deposit. \$150/night + tax. Use discount code CATFAN9 here and other LQ hotels in the area including: La Quinta I-35N at Rittiman Rd, \$71.10/night +tax (32 miles); La Quinta South Park, \$80.10/night+tax (34 miles); La Quinta Gonzales, \$66/night+tax (30 miles); La Quinta Floresville, \$71.10/night+tax (36 miles).

Other area hotels include: **Motel 6** (use rate code 542766) New Braunfels, \$96/night+tax (12 miles); San Marcos, \$68/night+tax (23 miles); San Antonio East \$58/night+tax (29 miles); Splashtown \$54/night+tax (33 miles); **Super 8** Seguin, \$93/night+tax+\$15 pet fee.

**Fly-Ins** —The airport code is SAT and is approximately 40 miles west of the hotel.

**PLEASE NOTE SHOW RULE 6.15:** Only cats registered with CFA with either a temporary or permanent registration number are eligible for entry in the Championship and Premiership competitive categories and the Veterans, Provisional Breed, Miscellaneous (Non-Competitive) or AOV classes. The show management is expressly prohibited from accepting a Championship, Premiership, Veteran, Provisional Breed, Miscellaneous (Non-Competitive) or AOV entry unless the official entry form contains a registration number or request for a temporary registration number. Any AOV, Provisional or Miscellaneous kitten must have a registration number in order to be eligible to be shown.
