Per show rule 11.08a, each entry must be accompanied by stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to start of show. Odd numbered entries with ANY size security cage require the purchase of an extra 1/2 cage space. All championship, premiership and kitten entries with reg-istration numbers or temporary registration number will be scored for CFA national and regional points. Owners of novices can contact the Entry Clerk for a temporary registration number.

Show Hall: Illinois State Fairgrounds, Orr Building, 801 E. Sangamon Avenue, Springfield, IL 62702; (217)782-6661. The show hall is handicapped accessible, non-smoking and air-conditioned. Parking is free. Enter the Fairgrounds through Gate 8 or 9 off of North 8th Street.

Airport: Abraham Lincoln Capital Airport in Springfield (SPI). As an alternative, Lambert St. Louis Airport (STL) is about 1-3/4 hours away.

Check-In and Show Hours: Check-in Saturday 8:00 – 9:30 am. Judging will begin promptly at 10:00 am on Saturday and 9:00 am on Sunday.

Show Hotel: Holiday Inn Express, 3050 S Dirksen Parkway, Springfield, IL 62703; (217) 585-2835. Check other nearby hotels for their pet policies.

Cages: A single cage measures 21"x21"x21"; a double cage measures 21"x 21"x42". Odd numbered entries with ANY size security cage require the purchase of an extra 1/2 cage space. Bring litter pans and food. Litter will be provided.

Rules: It is advised that all entries be tested by FELV and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus and Rabies before entry. Class of all feet meet must be clipped prior to benching. No declawed cats allowed. All cats must be free of fleas, fungus, ear mites and any contagious illness.

Show Management reserves the right to cause removal cat from the show hall if any of the above conditions are suspected until a licensed veterinarian can make an examination at the exhibitor's expense. All championship, premiership and registered kitten entries will be scored for CFA regional and national awards. This show is conducted under the current CFA rules. Rules are available for \$7 from CFA, 260 East Main Street, Alliance, OH 44601.

Liability: America's Heartland will take reasonable care to safeguard property of exhibitors. Neither the club, its members or the Illinois State Fairgrounds will be liable for loss or damage. No guard will be on duty Saturday night. Cats must be removed from show hall during the overnight hours.
