**KITTY LITTER WILL BE PROVIDED.** Exhibitors should bring their own litter trays, cat food and dishes. Novice exhibitors, note that you need to bring cage curtains or towels. Cage size is 22" x 22" x 22".

It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhino tracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

**ROSETTES AND RIBBONS** will be awarded in accordance with CFA show rules, which will govern the show. A copy of the rules and show standards is available for a nominal fee from CFA 260 E. Main St. Alliance, OH 44601. All rings will use permanent ring designations. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. The club reserves the right to add judges not named in the show announcement to judge non-championship and non-premiership classes.
