The show hall is heated & air  
conditioned and is handicapped  
accessible. People food will be  
available in the show hall.

**Entry:** All online entries must be confirmed by email or phone call to the Entry Clerk. All fees and benching request must accompany entries. Fax entries will be accepted. No emailed, phone entries or post dated checks will be accepted, and all funds must be in US currency. *Make checks payable to Black Diamond Cat Club.* Only one benching request per exhibitor will be honored. Mailed entries must be printed or typed on an official, signed CFA entry form. The entry clerk will call collect if questions arise concerning your entry.

**Check-in** is from 8:00-9:30 on Saturday. Any cat not benched by 9:30 will be marked absent. Judging will begin at 10:00 on Saturday & 9:30 AM on Sunday. Please report any transfers or absentees at check-in. All adult entries must remain in the show hall during advertised hours of 10:00 AM- 5:00 PM. Cage size is approximately 22"x22"x22", bring cage curtains (or coverings) to cover the sides, top and bottom of cage. New exhibitors are advised to bring cage drapes or towels, etc. for the floor, sides and top of the cage. Please advise the entry clerk if this is your first show. Litter will be provided but not litter pans.

**Show Hall:** people food will be available in the show hall. The show hall is heated and air conditioned and handicapped accessible.

**Show Hotel:** Hampton Inn 4 North Pottstown Pike (\*\*For GPS Mapping Systems Use: 600 W. Uwchlan Ave. Exton PA\*\*) Exton, Pa 19341 Phone: 610-363-5555. There are also a Holiday Express and an Extended Stay in the area.

**Additional Info:** All championship, premiership and kitten entries with registration numbers will be scored for CFA National and Regional points. No declawed entries are permitted and all entry's front and rear claws must be clipped prior to benching. No kittens under 4 months are permitted in the show hall or on the show grounds. No cats or kittens may be left in the show hall overnight. Only benched cats and kittens are permitted in the show hall, none may be confined in carriers. This is a non-vetted show, and all entries are expected to be inoculated against feline enteritis, Rhinotracheitis, Calici virus and rabies and to be tested negative for FeLV. The exhibitor of any entry showing evidence of fungus, fleas, ear mites or any contagious disease will be asked to remove that entry as well as their other entries from the show hall. By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. CFA show rules may be obtained for \$7.00 each from CFA, 1805 Atlantic Avenue, Manasquan, NJ 08736.
