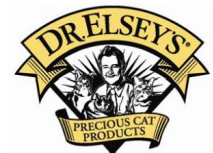

Show Hall: Hall of Flowers building this year, heated for a warm comfortable show. There will be people food available in the show hall. This is a no smoking show hall.

Cages: Single 21x21x21, Double 21x21x45. No more than 1 cat or 2 kittens may be benched in a single cage.

Entry Fees:

HHP \$35.00 (HHP are not included when calculating discounts for non-HHP entries)

Double Cage: \$25.00 **All security cages, Singles and Doubles, require a double cage space, \$25.00 Double Cage fee applies.**

Agility: \$10.00 prepaid with your entries, or \$12.00 if you decide to try agility after you get to the show hall

Health Information: This is a non-vetted show, however any entry found with fleas, ear mites, fungus or any signs of illness will not be admitted or will be removed from the show hall. All cats and kittens should be inoculated against Feline Enteritis, Rhinotracheitis, and Calci viruses and should be tested for feline FeLV. All claws must be clipped prior to benching. Declawed cats are not allowed.

Awards: All Championship, Premiership and registered kittens (whose registration number is printed or written in ink in the catalog) will be scored for Regional & National awards in accordance with DFA Show Rules.

Liability: Although normal precautions will be taken, Call of the Wild and the Santa Rosa Fairgrounds will not be liable for damage, loss of personal property or personal injury.

Cat Comfort: Cat litter will be provided by Almost Invisible Cat Litter. Please bring your own litter boxes, cat food and dishes.

Directions to the Show Hall: North or South on Hwy. 101, Exit Hwy 12 Sebastopol/Sonoma off ramp. Take Hwy 12 East towards Sonoma. Exit Hwy 12 at South E Stree/Downtown. (It's the first exit you come to) continue straight. This is Bennett Valley Rd. The Show Hall is the Hall of Flowers Building on the right next to the Grace Pavilion..

Return to Hwy 101: Bennett Valley Rd is one-way. Exit the Fairgrounds on Bennett Valley Rd. At the first light, Brookwood Ave, turn left. Turn left again at the next street, Maple Ave. Maple leads onto Hwy 12 W and easy access to North or South bound Hwy 101.
