All fees must accompany entries. **For email and fax entries, fees must be sent within 10 days of the entry** to insure confirmation of entry. The fee for returned checks is \$75. **WAIVE SIGNATURE** on overnight entries.

Show Hall

The show will be held in the spacious Sportsplex Indoor Sports and Event Center, 221 Commonwealth Ct., Winchester, Va. 22602 (540-868-2200). The building is heated and handicap accessible. No smoking is allowed in the show hall. Directions will be sent with confirmation.

Benching / Show Hours

Check-in is from 8:00am - 9:30am Saturday morning. Judging begins at 10:00am on Saturday and 9:00am on Sunday, unless otherwise announced. Advertised show hours are Saturday 10:00am to 5:00 pm and Sunday 9:00am to 4:00pm.

Awards

Ribbons and rosettes will be awarded in each ring in accordance with CFA rules. Championship, premiership, and registered kittens whose numbers appear in the catalog will be scored for national/regional awards.

Cages / Supplies / Food

Cages are approximately 24"x24"x24". New exhibitors should bring fabric and clips for the floor, sides, and tops of cages. Litter will be provided; bring your own litter pan. People food will be available. **NO OUTSIDE FOOD IS ALLOWED IN THIS FACILITY.**
