**SHOW RULES & SCORING:** This show is licensed by The Cat Fanciers' Association. The CFA Show Rules will be enforced (download a complete copy at no charge from <http://www.cfa.org/Portals/0/documents/forms/13-14showrules.pdf> or order online for \$7 from <http://catalog.cfa.org/pubs.shtml#showrules>).

Submit official entries to comply with Show Rules in Articles IV and XI. Entries sent online or faxed must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Owners of novices can contact the entry clerk for a temporary registration number. All Championship, Premiership, and Kitten entries with a registration number or temporary registration number will be scored for CFA National and Regional Awards. Declawed cats are not eligible for entry. All claws of all entries must be clipped prior to benching. No kittens under 4 months old in the show hall. This is a non-vetted show, and all cats and kittens should be inoculated against feline enteritis, rhinotracheitis, calici viruses, rabies, and tested negative for FeLV. The exhibitor of any entry showing evidence of fungus, fleas, ear mites, or any contagious disease will be asked to remove that entry and all additional entries from the show hall. No cats or kittens may be left overnight. The club, its members, show services, and the Cabarrus County Events Center are not liable for any loss or damage.

**AGILITY ENTRY:** All are welcome to enter agility cats. For cats not entered in the show, it is mandatory you pre-enter your agility cat using the form on the CFA Agility web site. The fee for cats not entered in the show is \$30, which includes an extra 1/2 cage space. For cats entered in the show it is preferred you pre-enter your agility cat using the form on <http://agility.cfa.org>. Entries will also be accepted at the show. The fee for cats entered in the show is \$10.

**BENCHING:** One bench or agent request per exhibitor will be honored when possible. Please put request on entry form. No refunds for failure to bench. Show Manager approval required for benching changes at show. *Single entry with ANY size security cage or end of row must purchase an extra 1/2 cage.*

**SUPPLIES & MISC:** Litter will be provided, but not litter pans. Single cage size is 22" x 22" x 22". All exhibitors are required to bring cage curtains/coverings for the floor, sides, and top of the cage, unless using a security cage. None may be confined in carriers. Onsite food vendor and area restaurants available.

**FLYING IN?** Charlotte-Douglas International Airport (CLT) is a 45 to 60 minute drive from the show hall. Rental cars are available at the airport.
