**Entry Fees:** Fees MUST accompany the entry form. A \$2 per entry fee will be sent to Central Office to support CFA per show rules. **All entry fees received after December 5 must be accompanied by a \$50 late fee.**

**Entries:** Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. A \$50 fee will be charged on all returned checks. NOTE: We accept online & fax entries. Paid entries will be entered before online/fax entries. **THERE WILL BE AN \$8 FEE IF PAID AT THE DOOR;** pay-at-the-door fee waved if payment is received PRIOR to November 28, 2015. No refunds once your entry has been received or for failure to bench.

**Hours:** Check-In is 7:30-8:30 am. Cats not checked in by 8:30 am will be marked absent and the exhibitor must check in with each ring clerk. Show hours for exhibitors are 9 am -5 pm Advertised show hours Sat 9 am - 4 pm.

**Show Hall:** The Melbourne Auditorium, 625 East Hibiscus, Melbourne, FL 32901 phone 321-674-5700. The show hall is both heated and air-conditioned as needed. This is a Non-Smoking facility. Lots of Free Parking for exhibitors and spectators.

**Show Hotel:** Melbourne Airport Hilton 200 Rialto Place, Melbourne, FL 32901, 321-768-0200. Show rate is \$85 per night with a \$50 refundable pet deposit. Please leave rooms clean and sweet smelling as we want to be invited back.

**Supplies:** Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. Exhibitors in violation will be told to leave the show hall.

**General:** CFA Show rules will be strictly enforced. A copy of the rules may be obtained for \$7 from CFA, CFA 260 East Main Street - Alliance, OH 44601 | Office: (330) 680-4070. All cats/kittens must have all claws clipped prior to benching. **Declawed cats are not eligible for competition.** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Owners of novices can contact the entry clerk for a temporary registration number. It is the Exhibitors responsibility to check entry confirmation and notify entry clerk of any errors.

**Benching:** All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. Benchng requests made at the time of entry will be honored whenever possible. **Remember this is a request, not a guarantee. PLEASE, NO NEGATIVE REQUESTS.**
