**Show Hall:** The Omni Auditorium (Broward College) is located at 1000 Coconut Creek Blvd, Coconut Creek, FL 33066. The telephone number at this facility is (954) 201-2233. Smoking is not permitted in the show hall or rest rooms. Those who wish to smoke, must do so in the outside areas adjacent to the front entrance of the show hall.

**Show Hotel:** The Comfort Suites, 1040 E. Newport Center Dr. Deerfield Beach, FL 33442. The local telephone number is 954-570-8887. Ask for the cat show rate of \$67.95 per night plus tax. Room block is reserved under <u>CATS EXCLUSIVE SHOW</u>, make your reservations by **10/01/11**. You will be asked to sign a pet agreement when you check-in, saying you will be responsible for any damage, so take good care of your rooms. The Comfort Suites is located just off 1-95 at exit 41. Take 10<sup>th</sup> Street west one block, and turn left onto E. Newport Center Drive. Hotel is on the left side. Please note, the Comfort Suites is a **non-smoking** hotel.

Kitty Halloween Costume Contest: Cats Exclusive is having a Kitty Halloween costume contest. Dress your kitty in their finest, and join our Halloween Parade. Our judges will pick the scariest, silliest and prettiest costumes. There will be prizes awarded for all the winners. All kittys entered in the show are welcome to participate.

**Awards:** Rosettes will be awarded in all rings for final wins. Permanent ribbon designations will be placed on judging ring cages for wins of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place, and Best and 2<sup>nd</sup> Best of Color/Breed. Exhibitors may request satin ribbons from the club booth.

**Food Concession:** There is a food concession at the Omni Auditorium. The concession is located outside, just to the left of the front entrance under the overhang. Hours are from 8 AM to 4PM Saturday and Sunday. Food, snacks, coffee and soft drinks are availavailable.

Handicap Parking: Handicap parking is available at the Omni Auditorium. The first row in the exhibitor parking lot is reserved for handicap parking. You must display your state issued handicap parking permit (from your rear view mirror) to park in the designated handicap parking area. **General Show Info:** All kittens must have registration numbers printed or written in ink (in Master Clerk's show catalog) to be eligible for scoring. All Championship and Premiership entries must have registration numbers on entry forms to be accepted. All Championship, Premiership and Kitten entries will be scored for CFA Regional & National Awards.

CFA Show Rules (\$7.00) or Show Standards (7.00) may be purchased from the club booth during the show, or from CFA 1805 Atlantic Avenue, Manasquan, NJ 08736-0805.

*Exhibitors are expected to supervise their children at all times.* The show management will take all reasonable care of cats, carriers and exhibitor property; however, neither show management nor club members, show officials, city employees or sponsoring club shall be liable for any loss or damage to such property.

There will be no veterinary inspection prior to benching. It is expected that all exhibitors will have their cat's vaccines up to date. It is also expected that all entries will be free of fleas, and have their claws trimmed. No cats may be left overnight in the show hall.

**Entry Confirmations:** All entry confirmations will be e-mailed unless USPS mailing is requested.

**Benching:** Check-in will be 7:30 AM to 8:30 AM Saturday morning, with judging starting at 9:30 AM. Exhibitors arriving after 8:30 AM, must notify the Master Clerk, and each ring clerk of your cat's presence. Judging begins 9:00 AM Sunday, unless otherwise announced Saturday afternoon. Show hours are 9:00 AM to 5:00 PM on Saturday, and 9:00 AM to 4:00 PM on Sunday. The show hall will be open to exhibitors and vendors at 8:00 AM on Sunday morning.

**Entry Information:** Entry fees include one catalog, free parking (both days), a single cage (22x22x22) per entry and litter. **Exhibitors must bring their own litter pans**. All fees must accompany entries, unless faxed or e-mailed. Last minute bounced checks must be paid (along with \$35.00 fee) in cash at check-in Saturday morning. <u>All payments at the door must be in cash only</u>. No entry fees will be refunded for failure to bench. Only one benching requests. Substitutions are for same owner only.
