<p><b>ENTRIES</b> must be submitted on an official CFA entry form which may be obtained from the CFA at <a href="http://www.cfa.org">www.cfa.org</a>. Entry forms can be sent by regular mail, email, fax, or entered online at <a href="http://catshows.us">catshows.us</a>. All fees must be paid within ten days of entry per CFA Show Rules. PayPal is not available. Make checks payable to Cat Fanciers of Washington. WAIVE SIGNATURE for overnight deliveries. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.</p> <p><b>THE SHOW HALL</b> is the Winchester Sportsplex, 221 Commonwealth Court, Winchester VA 22601, 540-508-2555. The building is heated and air-conditioned and handicap accessible. No smoking permitted in the show hall. Directions will be sent with the acknowledgement.</p> <p><b>AWARDS</b> – Ribbons and rosettes will be awarded in each ring in accordance with CFA show rules. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens can contact the entry clerk for a temporary registration number.</p> <p><b>CAGES / SUPPLIES / FOOD</b> – Cages are approximately 22”x22”x22”. New exhibitors should bring fabric and clips for the floor, sides, and top of cages. Litter will be provided; bring your own litter pans. People food will be available. NO OUTSIDE FOOD IS ALLOWED IN THIS FACILITY.</p> <p><b>Local Airport Info:</b> Dulles is about 53 miles; Regan is about 78 miles and BWI is about 100 miles.</p> <p><b>HOTELS</b> – The following hotels accept pets: Country Inn &amp; Suites, Winchester VA, 800-830-5222 Red Roof Inn, Winchester VA, 540-667-5000 Towne Place Suites, Winchester VA, 540-722-2722</p> <p><b>GENERAL INFORMATION</b> – All entries are expected to be free of mites, fleas, fungus, and infectious illnesses. It is strongly advised that all cats/kittens entered or present in the hall be inoculated by a licensed veterinarian against panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats/kittens be tested &amp; found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible to compete. All Household Pets over the age of eight months must be neutered or spayed. No kittens under four months old will be allowed in the show hall.
