**Hours:** Benching will be from 7:30 to 8:30 a.m. and the advertised show hours are 9:00 a.m. to 5:00 p.m. or the end of finals.

Per CFA Rules, your check must accompany entries or payment must be made within 10 days of on-line entry or the start of the show, whichever comes first; no post-dated checks or phone entries.

Booth Space: Booth rates are \$75 for a single (12' wide x 8' deep) space and \$125 for a double (24' wide x 8' deep) space. Each space includes 1 table; additional tables available for \$10 each. Contact JoAnn Brubacher, 715-302-5868, luvnmittens@aol.com

The Expo Center concession will have people food for sale. Our contract with them specifically prohibits bringing in food from outside. Please do not bring coolers inside and help us protect our show hall.

All entries must be registered with CFA, except kittens, novices and household pets. Kittens must be registered for CFA National and Regional scoring and to be included in the count - registration numbers must be printed in the catalog or provided to the Master Clerk. All Championship, Premiership and registered Kittens will be CFA scored. No kitten under 4 months of age will be allowed in show hall, exhibitors must have litter registration available to verify kitten's age. Only 2 cats or 4 kittens allowed per double sales cage. No kitten sales from the vending area. No cats allowed in show hall that are not entered or benched in sales cages.

Show hall is air conditioned, heated and is handicapped accessible. Handicapped benching requests will be accommodated, at no additional charge to the exhibitor. Free parking available. A map will be posted on the club website and with the flyer on the Midwest Region site.

# In accordance with Wisconsin state statutes and CFA rules, there will be NO SMOKING in the show hall.

There will be no veterinarian inspection prior to benching. All cats must be free from fleas, ear mites or any infectious or contagious illness. You are advised to have your cat inoculated by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici virus and rabies and tested for feline leukemia virus before entry. Front and rear claws must be clipped prior to benching. No declawed cats may be entered. Parents are expected to supervise their children at all times! CFA SHOW RULES WILL BE IN EFFECT. Copies of CFA Show Rules may be obtained for \$7.00. Show Standard is free for individual breed or \$9.00 for complete set. Contact CFA Central Office, 260 Main Street, Alliance, OH 44601. **Supplies:** Litter will be furnished. Please bring your own litter pan. Bring your own cat food, food and water dishes.

**Cages:** Approximate size is 21" x 21" x 21" (single cage, one-half of double, wire cage, included with entry). Second entry by same owner will be benched in the other half of a double cage, or the other half may be purchased for extra \$25 (noted as extra half cage), as available. Exhibitors using security cages must purchase extra half cage space if exhibiting one cat in the cage. Single security cage spaces are not available.

Bring your cat to the show hall in a carrier or other sturdy container. You will need drapes or towels to hang on the inside and to cover the top and the bottom of the cage. Reasonable care will be taken of all cats and personal property, however, the show management is not responsible for anything lost or damaged.

**Show Hotel:** No official Show Hotel. Area hotels include: **La Quinta—Milwaukee West**, 20391 W. Bluemound Road, Brookfield, WI, 855-809-3504 or 262-782-9100 and **Motel 6 - Milwaukee West Brookfield**, 20300 W. Bluemound Road, Brookfield, WI, 262-786-7337. These hotels are about four miles from the show hall.
