

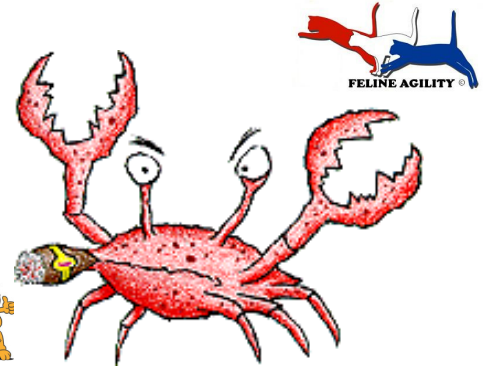

**Entry Information:** **Entry Fees include CFA surcharges.** It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online or fax entries. The Entry Clerk or Club will not be responsible for entries lost due to communication errors. Per show rule 11.08 a.; all entries *must* be accompanied by proper entry fees. Entries sent online or faxed *must* be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Crab & Mallet. **PayPal** payments will be accepted **PRIOR TO CLOSING DATE**; contact the entry clerk for payment info. No substitutions accepted after the closing date. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. Only **ONE** benching request will be allowed; you may choose **either an agent or a benching request**. If you request an agent, additional benching requests may not be honored.

**Show Hall:** Pikesville Armory 610 Reisterstown Rd. Baltimore, MD 21208. Phone number: 410-653-6732. This is a non smoking, heated and handicapped accessible show hall. Handicap parking is available. The club will exercise care with the sponsorship of the show. The club, its members, nor the show hall facility will be liable for any loss or damage.

**Benching:** Check in is Saturday from 8 to 9:30 am – show starts at 10 am Saturday and 9am on Sunday. Advertised show hours are until 4 pm on both days. This is a non-vetted show. All cats & kittens are expected to be free of fleas, fungus, ear mites, and other diseases. Any evidence of disease detected by a judge and or brought to the attention of the show committee will be handled in accordance with CFA show rules. All entries should be inoculated against Feline Enteritis, Rhinotracheitis and Calici viruses and tested for Fe-LV by a licensed vet. CFA rules require that cat's front and back paws be clipped prior to benching. Cages are approximately 22" x22" x 22". Litter will be provided. Please bring your own litter box whether using show litter or not.
