Show Hours Check-in 8:00-9:30 a.m. Judging will begin at 10:00 am on Saturday and 9:00 am on Sunday. Cats not checked-in by 9:30 a.m. will be marked absent. The advertised show hours are 10:00 am - 5:00 pm Saturday and 9:00 am - 4:00 pm Sunday. The show hall is handicapped accessible, heated and air-conditioned. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. CFA Show Rules will be strictly enforced. This is a non-vetted show. Claws of all entries must be clipped prior to benching. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Any entry suspected of having a parasite, skin disease or other illness will be removed from the show hall until cleared by a veterinarian, whose decision is final. Household Pets must be 4 months old to be entered and if over the age of 8 months must be neutered or spayed. Household Pets will be scored in all 8 rings, and rosettes and trophies will be awarded for the top 10 in each ring. No declawed cats are permitted. No kittens under 4 months of age will be allowed in the show hall. Single cages are approx. 22 x 22 x 22. Working club members will receive a rate of \$40 per entry. Novice Exhibitors: Let us know if you are new to showing. We are happy to help you learn about CFA and showing. Please bring cage curtains, grooming aids, your own litter pans and food. People food will be available. Litter will be provided. All cats must be brought to the show hall in some sort of carrier.
