No refunds if your cat is entered and is not at the show. *ANY fee paid at the door must be in cash.* CFA Show Rule: Payment is DUE by the day of the show. Entries must be typed or printed legibly, signed and submitted on an official CFA entry form or acceptable online copy. Only one benching request, either agent or person; we cannot bench by breed. All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. *Anyone with an odd numbered entry using a Sturdi or similar personal cat cage must purchase additional half cage (\$30).*
