General: CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$5 from CFA, PO Box 1005, Manasquan, NJ 08736. All cats/kittens must have all claws clipped prior to benching. **Declawed cats are not eligible for competition.** All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional Awards. Registration numbers of cats must be printed in the catalog; registration numbers of kittens can be submitted at the show to the master clerk. It is the Exhibitor's responsibility to check entry confirmation and notify entry clerk of any errors.

Benching: All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. Benching request made at the time of entry will be honored whenever possible. No refunds for failure to bench.

Flying In? The Philadelphia International Airport is approximately 45 minutes away. Shuttle service is available to the show hotel for approximately \$40 one way.

Special awards: The Laina Aitken Memorial Award will be given to the highest scoring Siamese. An award will be given to the highest scoring HHP in each ring. Other special awards may also be given and will be noted as such in the catalog.
