**Supplies:** Litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

**Health:** This is a non-vetted show. Exhibitors are strongly encouraged to have cats and kittens inoculated. Cats must be free of fungus, fleas, ear/body mites and contagious diseases. Exhibitors in violation will be told to leave the show hall.

**General:** CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 East Main Street, Alliance, OH 44601. All cats/kittens must have all claws clipped prior to benching. **Declawed cats are not eligible for competition.** All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional Awards. Registration numbers of cats must be printed in the catalog; registration numbers of kittens can be submitted at the show to the master clerk. It is the Exhibitor's responsibility to check entry confirmation and notify entry clerk of any errors.

**Benching:** All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. Benching requests made at the time of entry will be honored whenever possible. No refunds for failure to bench.

**Flying In?** The Philadelphia International Airport is approximately 45 minutes away. Shuttle service is available for approximately \$50 one way. Frontier Airlines flies into New Castle Airport (Wilmington, DE). Shuttle service is available from Delaware Express.
