ENTRIES: Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Entry clerk will call COLLECT if any questions arise concerning your entry. A \$50 fee will be charged on all returned checks. We will accept fax, online and email entries. A \$5 (per exhibitor) additional charge will be assessed if payment is made at check in.

HOURS: Check-in on Saturday 7:30 am - 8:30 am. Advertised show hours are 9:30 am-4:00 pm. Judging will begin at 9:00 AM. SHOW HALL: Deland National Guard Armory, 4011 Alabama Avenue, Deland, Florida. The show hall is a non-smoking, air conditioned facility. Parking is free.

GENERAL: CFA show rules will be strictly enforced. A copy of the rules may be obtained for \$5 from CFA, P.O. Box 1005, Manasquan, NJ 08736. All cats/kittens must have all claws clipped prior to benching. <u>Declawed cats are not eligible for</u> <u>competition</u>. All championship, premiership and registered kittens will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog; registration numbers for kittens can be submitted at the show to the master clerk. It is the exhibitor's responsibility to check entry confirmation and notify entry clerk of any errors when the confirmation is received.

BENCHING: All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. <u>No refunds for failure to bench.</u> Cages measure 22"W × 22"H × 22"D.
