All Entries must be submitted on an official CFA entry form or facsimile, accompanied by the proper fees. CFA registration numbers must be included for all Championship, Premiership and A.O.V. classes. Kittens must be four months old by the date of the show. Make checks payable to <u>EMPIRE CAT CLUB</u>. All checks must be drawn on U.S. banks or in U.S. funds. <u>Exhibitors MUST confirm fax or email entries by phone or email with entry clerk!</u>

**STARTING TIMES:** The Show Hall will open at 9:00 a.m. **All cats must be benched by 9:45 a.m.** or they will be marked absent. Judging will begin **<u>PROMPTLY at 10:00 a.m. on Saturday</u>**. All entries must remain in the Show Hall until 4:30 p.m. on Saturday unless permission is received from the Show Manager.

Cages approximately 22"x22"x22". Litter will be provided. All entries should be inoculated against Feline Enteritis, Rhinotracheitis and Calici Viruses and tested FeLV by a licensed vet. Cats should be free of mites, fleas and fungus. CFA Rules require that your cat's front and back claws be clipped. NY State requires a rabies certificate be available for all entries. This is a non-smoking facility, smoking inside the show hall is not allowed. Show hall is NOT climate controlled.

Our show is held under the auspices of the Cat Fanciers Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$5.00 from <u>CFA, PO BOX 1005, MANASQUAN, NJ 08736-1005</u>. The club has the right to add judges not named in the show announcement to judge non-championship and non-premiership classes. All championship, premiership and registered kittens will be scored for CFA National and Regional awards.

Cats will not be permitted in the show hall overnight. The club will exercise due care on the sponsorship of the show, but will not be liable for any loss, damage or injury. No watchman will be provided during hours the show is not open.
