**Show Hall:** Maryland State Fairgrounds 2200 York Rd. Timonium, MD 21093 Ph: 410-252-0200. The show hall is handicapped accessible and air conditioned. People food will be available.

**Entry Info:** Entries are accepted now. *Fees include CFA surcharges.* It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online or fax entries. Neither the Entry Clerk or Club will be responsible for entries lost due to communication errors. **Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE.** Per show rule 6.21; all entries *must* be accompanied by proper entry fees. Entries sent online or faxed *must* be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Freestate Feline Fanciers. *Returned Check Fee is \$50 (plus bank fees).* No substitutions will be accepted after the closing date. No refunds made once your entry is received or for failure to bench. **Single entry with ANY size security cage requires the purchase of an extra 1/2 cage.**

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count.

**Awards:** Rosettes will be awarded and permanent flats will be used in accordance with CFA show rules. All show rules will be strictly enforced. Copies of the show rules are available for \$7 from CFA 260 East Main St. Alliance, OH 44601.

**Health:** All entries should be inoculated against Panleukopenia, Rhinotracheitis and the Calici Viruses, and we recommend that they be tested for FeLV prior to entering the show hall. All cats must be free of mites, fleas, fungus and any contagious illnesses. All claws (front and back) must be clipped prior to benching.

**Fly-ins:** Baltimore/Washington International (BWI) is approximately 35 miles from the show hall and show hotel. Exhibitors are responsible for their own transportation.

**Household Pets:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

**Liability:** Freestate Feline Fanciers will take reasonable care to safeguard entries and the property of exhibitors. Neither the club, club members nor the Maryland State Fairgrounds will be liable for any loss, damage or injury. The sponsoring clubs reserve the right to add or substitute judges not named in show flyer should it become necessary.

**Supplies:** Bring your own litter pans. Club will provide litter. Individual cage size is 22" X 22" X 22" and is included with your entry.
