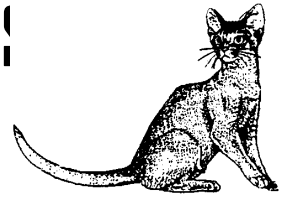

Entry: All fees and benching request must accompany entries. Only one benching or agent request per exhibitor will be honored. Print or type all information on an official, signed CFA entry form. The Entry Clerk will call collect if questions arise concerning your entry. NO phone entries or post dated checks. Please waive signature on all overnight mailings.

Show Hall: DELAWARE COUNTY FAIRGROUNDS, 236 Pennsylvania Ave., Delaware, OH 43015; Phone: (740) 362-3851
Show hall is heated and air-conditioned. **NO SMOKING IN SHOW HALL.** Show hall is handicapped accessible. Reasonable care will be taken of cats and personal property, but show management, G.L.A.D., Delaware County Fairgrounds and Delaware, OH are not liable for any loss, injury or damages. No cats may be left in show hall overnight.

Show Hours: **Saturday:** Check in 7:30 a.m. to 8:30 a.m. Show hours are 9:00 a.m. to 5:00 p.m.

Supplies: LITTER will be furnished. To be safe, bring your own cat food, water/food dishes and litter pans.

Cages: Size approximately 22" x 22" x 22". Bring cage curtains or towels to cover sides, top & bottom of cage.

Catalog Ad: \$50.00 FULL PAGE, \$30.00 HALF PAGE AND \$5.00 BUSINESS CARD. All ads must be camera ready.

Health: No veterinarian inspection will be required prior to benching. Inoculations for Enteritis, Rhinotracheitis, rabies, and calici virus plus FELV testing should be up to date. All cats and kittens are expected to be free of fleas, fungus, ear mites and other diseases. All claws (front & rear) must be clipped prior to benching.

Eligibility: Only CFA registered cats are eligible for entry. Kittens need not be registered but must be registerable and NO kitten is permitted in show hall less than 4 months of age. NO declawed cats/kittens allowed.

Show Rules: CFA show rules will be strictly enforced. Copies of show rules are available by sending \$5.00 to CFA, PO Box 1005, Manasquan, NJ 08736.

Food: Food services for exhibitors and visitors will be available at the show hall.

Flying In: Sorry, but you will have to provide your own transportation.

Awards: All ribbons/rosettes required by CFA show rules will be awarded. Designated flats will be used where applicable. Cloth flats will be available upon request. G.L.A.D. reserves the right to substitute judges. All championship, premiership and registered kittens will be scored for CFA National and Regional awards.
