SHOW HOURS:

Check-in: 9:30 to 10:30 AM

Show Hours: 11:00 AM to 6:00 PM

All entries are expected to remain in the show hall until the advertised closing time. Early departure without permission of the show manager will result in all wins being voided. Kittens are exempt from this rule.

SHOW HALL: Lamar-Dixon Expo Center is handicapped accessible and heated & air conditioned. Smoking is not permitted in the show hall. The Expo Center will have a concession stand. Grand parties are welcome. Litter will be provided; please bring your own litter pans, cat food and cage curtains.

NO KITTENS UNDER 4 MONTHS of age will be allowed in the show hall. This rule will be strictly enforced. Only those cats/kittens entered in the show will be allowed in the show hall.

THIS IS A NON-VETTED SHOW. All entries should be vaccinated by a licensed veterinarian against feline panleukopenia, feline rhinotracheitis, calici virus and rabies, and be tested for feline leukemia before entry. Cats must be free of fleas, ear mites, fungus and any contagious illness. All claws must be clipped. Declawed cats are not eligible for entry.

ENTRIES: All fees must accompany the entry. No entry fee will be refunded for failure to bench. There will be a \$50.00 charge for returned checks. Please inform the entry clerk if you are bringing your own cages. Note: Security cages w/1 entry require the purchase of an extra 1/2 cage space.

SCORING and AWARDS: Championship, premiership and registered kitten entries will be scored for CFA national and regional awards. Ribbons and rosettes will be awarded according to CFA rules. This show is licensed by The Cat Fanciers' Association, Inc. (CFA), and its show rules will be strictly enforced. A copy of CFA show rules can be obtained for \$7 plus \$2 shipping & handling from The Cat Fanciers' Association, Inc., 260 East Main Street, Alliance, Ohio 44601, or at www.cfa.org.
