Entries: Closing Date is September 28, 2009 or when 225 entries have been received, which ever comes first. * All Additional Entries must be from the same owner. Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. Entry clerk will call COLLECT if any questions arise concerning your entry. Make checks payable to Greater Lancaster Feline Fanciers. A \$5 Pay at the Door Fee will be charged to anyone paying at the door, **FOR ANY REASON.** A \$50 check fee will be charged on all returned checks. Fees **MUST** accompany the entry form. Paid entries will be entered before Online/Fax entries. No refunds for failure to bench. **Clerks contact Carol Schwartz 717-951-5716.**

Hours: Check-In on Saturday 7:30 a.m. - 8:30 a.m. Advertised show hours for exhibitors are 9:00 a.m. - 5:00 p.m.

Show Hall: The Show Hall is both heated and air-conditioned. This is a Non-Smoking facility. Parking is free for exhibitors and spectators. The Fairgrounds office telephone number is 717-848-2596. The emergency number is 911. WE HAVE GOOD PEOPLE FOOD!

Supplies: Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

Health: This is a non-vetted show. Exhibitors are strongly encouraged to have cats and kittens inoculated for FeLV/FIV. Cats must be free of fungus, fleas, ear/body mites and contagious diseases. Exhibitors in violation will be told to leave the show hall.

General: CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$5 from CFA, PO Box 1005, Manasquan, NJ 08736. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional Awards. Registration number of cats must be printed in the catalog; registration numbers for kittens can be submitted at the show to the master clerk. It is the Exhibitors responsibility to check entry confirmation and notify entry clerk of any errors.

Benching: All benching will be by exhibitor and no changes in assignment will be allowed without permission of the Show Manager. Cages are 22"W x 22"H x 22"D. One benching request made at the time of entry would be honored when possible.

Greater Lancaster Feline Fanciers reserves the right to substitute judges in case of illness or emergency.
