In order to keep this show/hotel, we need to book rooms at this hotel. **As an added incentive, GSLCC will refund \$10 per exhibitor/room/night when you bring your hotel receipt to the treasurer on Sunday.** Example – Sting stays 2 nights at show hotel, so would get \$20 on Sunday. Paul, George, Ringo & John share a room at the show hotel for 2 nights, so would get \$20 on Sunday. Brooks & Dunn share a room on Saturday night, so would get \$10 on Sunday. Maximum Refund \$20.

RULES: All entries should be FELV negative and be inoculated by a licensed veterinarian against Rhinotracheitis, Calici, Panleukopenia, and Rabies. All claws should be clipped; no declawed cats may be entered. All cats must be free of fleas, fungus, earmites and contagious disease. Show management reserves the right to remove from the showhall any entry suspected of any of the above until a licensed veterinarian can make inspection at the exhibitor's expense. Exhibitors should bring cage drapes, litter pans, food/dishes. Litter will be provided. All Championship, Premiership, and kittens with registration numbers will be scored for CFA regional/national awards. This show will be conducted under current CFA rules. CAGES: Single cages are 21" X 21" X 21"; doubles are 21"X 42"X 21"

LIABILITY: GSLCC will take reasonable care to safeguard the property of exhibitors. Neither the club, its members nor the Doubletree Hotel St. Louis at Westport will be liable for any loss or damage. No guard service will be available Saturday evening and all cats must be removed from the show hall Saturday evening. The show hall is heated & cooled. Smoking permitted outdoors.

SALES CAGES: Available to exhibitors with at least one entered cat on basis of space availability. Kittens less than 4 months of age not permitted in show hall. Litter registration slip required for age confirmation. All animals for sale must be in a cage.
