Entry Fees: Entries must be typed or printed legibly, signed and submitted on an official CFA entry form. The use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the online entry form is considered to be your signature per CFA Show Rule 4.05. If faxing or using the online entry, please confirm receipt. No phone entries accepted. Entry clerk will call COLLECT if any questions arise concerning your entry. Fees MUST accompany the entry form. Make check payable to **Hidden Peak**. All fax or online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Paid entries will be entered before Fax and online entries. No refunds for failure to bench. Only one bench request per entry.

Show Hall: The Maryland State Fairgrounds Exhibition Hall 2200 York Road Timonium, MD 21093. The show hall is both heated and air-conditioned. This is a non-smoking facility. **FREE PARKING.**

Show Hours: Check in 8:30 a.m. to 9:30 a.m. on Saturday with judging beginning at 10a.m. Saturday and 9.am. Sunday. **Advertised hours:** 10:00 a.m. – 4:00 p.m. both days. All entries must remain in the show hall until the advertised closing time unless given permission from the show manager.

Show Hotel: Hampton Inn 11200 York Road Cockeysville Maryland 21030 410-527-1500. Queen or Doubles \$79, King (w/ fridge & microwave) \$89. 10% discount available at Silver Spring Mining Co., Damons, Outback or Michaels with room key. A shuttle is available to Show Hall.

Airport: Baltimore/Washington International (BWI) is 26 miles from the show hall.

Show Supplies: Litter will be supplied. Please bring your own litter pan, water bowl, and cat food. Cages are approximately 22x22x22. People food will be available for breakfast and lunch.

CFA Rules: All entries should be inoculated against Feline Enteritis, Rhinotracheitis, and Calici Virus and tested for FeLV by a licensed vet. Cats should be free from mites, fleas and fungus. CFA show rules require your cat's front and back claws be clipped. Our show is held under the auspices of the Cat Fanciers Association. CFA show rules will be strictly enforced. Copies of the show rules are available for \$5.00 from CFA P.O. Box 1005 Manasquan, NJ 08736. All championship, premiership and registered kittens will be scored for CFA National and Regional awards. Cats may not be left in the show hall after published show hours.
