Entry & Payment Info: Entries are accepted now. Entry Fees include CFA & Regional surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Hidden Peak. No substitutions after the closing date. **Late Fee (after 8/25/19) \$50.** No refunds after the entry clerk has confirmed your entry or for failure to bench. **Please have exact cash at check-in. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.**

Show Hall: Maryland State Fairgrounds 2200 York Rd. Timonium, MD 21093 Ph: 410-252-0200. The show hall is handicapped accessible and air conditioned. People food will be available. Parking is free.

Show Hours: Check-in Saturday: 8:30-9:30 am. Check-in Sunday: 7:30-8:15 am. Cats not benched by end of check-in will be marked absent; if the cat is present the exhibitor must notify the clerk in each ring. Judging will begin at 10 am on Saturday and at 8:30 am on Sunday. Advertised show hours are 9 am – 3:30 pm both days.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number

Cages: Individual cage size is 22" X 22" X 22" and is included with your entry fees. **Single entry with ANY size security cage requires the purchase of an extra 1/2 cage.** Bring your own litter pans. Club will provide litter. Sales cage is available with paid entries only.

Awards: Rosettes will be awarded and permanent flats will be used in accordance with CFA show rules. All show rules will be strictly enforced. Copies of the show rules are available for \$7 from CFA 260 East Main St. Alliance, OH 44601.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Fly-ins: Baltimore/Washington International (BWI) is approximately 30 miles from the show hall. Exhibitors are responsible for their own transportation. Light RailLink goes from BWI directly to the show hall.
