Hours: Check-in time is 7:30 a.m. to 8:15 a.m. Judging begins promptly at 8:30 am. Advertised show hours are 10:00 a.m. to 4:00 p.m.

Show Hall: The hall is air conditioned/heated. The show hall is NO SMOKING. Single cages are 21x21x21in; doubles are 21x21x45. No more than one cat or two kittens may be benched in a single cage. Litter will be provided. Please bring your own litter pan. The Lion's Gate Hotel and Conference Center, Northwest Region, High Sierra Cat Club and club members will not be responsible for any personal injury, loss or damage to personal property.

Parking for the hotel and show hall is free.

Directions: From I-80 take the Watt Avenue/Northbound. Left onto Palm Ave (into McClellan Park) to Luce Avenue. Look for the big multi-colored building.

Show Hotel: Lions Gate Hotel and Conference Center. Phone: 866-258-5651. \$79 for Queen Standard or Double Deluxe and \$109 for King Deluxe. There is a \$25 refundable pet deposit. **CUT OFF DATE FOR RESERVATIONS is May 24, 2013.** The Hotel offers free transportation to/from the Sacramento Airport. The show hall is about 2 blocks from the hotel.

Entries: Entries close at Noon on Tuesday, May 28, 2013 or when entry limit is reached. Please make checks payable to High Sierra Cat Club. Fees must be received with entries except fax or email entries which must be paid within 10 days of entry or at the show whichever comes first. Per show rule 11.08, once an entry is made, it may not be withdrawn and payment is required whether or not the entry is exhibited. Early bird entries must be received with fees no later than May 4, 2013. Faxed/email entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. There is a \$25 return check fee for any reason. Any entry for Championship, Premiership, Veterans, Provisional or AOV classes must be submitted with a CFA registration number. Benching requests are limited to one.

Awards: All championship, premiership and registered kittens (whose registration number is printed or written in ink in the catalog) will be scored for Regional and National awards in accordance with CFA show rules. A copy of the show rules may be obtained for \$7.00 by writing to the Cat Fanciers' Association, 260 E Main St Alliance, OH 44601. Show rules can also be obtained online at <http://www.cfa.org/Portals/0/documents/forms/12-13showrules.pdf> at no charge.

Health: This is a non-vetted show. However, any entry found with fleas, ear mites, fungus, or any signs of illness will not be admitted or will be removed from the show hall. All cats and kittens should be inoculated against feline enteritis, rhinotracheitis, calici viruses and should be tested for feline FeLV. All claws must be clipped prior to benching. No declawed cats may be in the show.
