**Entry Info**: Entry Fees: Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to the Huntsville Cat Club. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections **BEFORE CLOSING DATE**.

**Show Hours:** Check-in Saturday from 7:30 - 8:30 am. Judging begins promptly at 9 am Saturday and at 8:30 on Sunday. Show Hours are from 9 am - 5 pm Saturday and 8:30 am to 4 pm on Sunday.

**Show Hall:** Jaycee's Community Building, 2180 Airport Road, Huntsville, Al. 35801 PH: 256-883-5252. Detailed maps will be sent with confirmation. The show hall is well air-conditioned/heated and wheelchair accessible. No cats may remain in the show hall overnight. No smoking is permitted in the show hall. **There is no concession stand so feel free to bring your coolers. We will have a lunch break at noon each day. There are a number of restaurants and a grocery store very close to the show hall.** 

**Transportation:** Commercial transportation from the airport to the hotels is available as well as some of the hotels provide courtesy transportation. The club will be unable to provide other transportation.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count.

**General:** This is a CFA licensed show and all CFA show rules will be strictly enforced. For a copy of these rules, send \$7 to CFA, 260 East Main Street, Alliance, Ohio 44601. The club reserves the right to add judges not named in the show announcement to judge non-championship and non-premiership classes. Reasonable care will be taken to safeguard the property of exhibitors. The show management and the Jaycee's management will not be held responsible for any loss or damages. Cages/Supplies: Cages are approximately 24x24x24. Novice exhibitors should bring a towel or a rug to cover the floor and enough material to go around the sides and to cover the top of the cage, along with clips or safety pins to fasten the material securely to the cage. Litter will be furnished in the show hall. Bring your own litter box and food. This is a non-vetted show. All cats should be inoculated by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies, test for FeLV and be free of fleas. fungus, mites, internal/external parasites and contagious diseases. The show committee reserves the right to remove any cat or kitten from the show hall if suspected of having any of the above ailments until examined by a licensed veterinarian at the owner/agent's expense. Kittens under 4 months of age will not be permitted in the show hall. Proof of age may be requested. All claws of all entries must be clipped prior to benching. Declawed cats are ineligible to be shown. THE ARK INC. a no-kill shelter in Huntsville will be providing adult volunteers for stewards. The **ARK** is a non-kill shelter and the rescue work they do and the support given to the CFA and to our club is greatly appreciated. Our club and the community help to financially support the **ARK**.
