All Championship, Premiership and registered Kittens will be scored for CFA National and Regional awards. Entry fees will not be returned for failure to bench in accordance with Show Rule 4.07. Benching on Saturday will be from 8:00 AM until 8:45 AM, with judging to begin promptly at 9:00 AM. All cats must be checked in by 8:45 AM or they will be marked absent. The advertised show hours are 9:00 AM – 5:00 PM. One benching request will be honored if possible. If your cat is being handled by an agent, that is your benching request. You are reminded that cats and kittens should be vaccinated against Rhino, Calci and Panleukopenia, Felv tested and have their claws clipped. Litter will be provided, but please bring your own food and litter pans. A detailed map to the show hall and hotel information will be sent with your confirmation.
