The show is limited to 450 entries. Regular entries close December 1, 2008, at **12:00 NOON!**

**Entries:** All entries (including for sale or exhibition) must be on a signed, official CFA entry form or an exact copy. Entry clerk will call collect, if information is incomplete or illegible. There will be a \$3.00 charge for fax or e-mail entries. There is a \$25.00 fee for returned checks. Make checks payable to **Lewis & Clark LH Specialty**. All fees must be in U.S. funds and accompany entries. *No refund for failure to bench.* One benching request per exhibitor, please. Entry fee includes \$1.00 mandatory CFA surcharge.

**Health:** This is a non-vetted show. We ask that all cats and kittens be current on all vaccinations (FVRCP, FeLV, etc.). Under current CFA show rules, show management reserves the right to have any cat showing signs of illness, disease or parasites removed from the show hall, in order to protect other cats in the show. All claws must be clipped prior to benching. De-clawed cats are not eligible for entry. All household pet entries over 8 months of age must be spayed or neutered. No kittens under 4 months of age will be allowed in the show hall.

**For Sale/Exhibition Cage Rules:** Kittens must be at least 4 calendar months of age or older, and comply with all other CFA show rules. For sale or exhibition entries must be on a signed, official CFA entry form or a facsimile.

**Hotel: Show hotel is Doubletree Hotel at Lloyd Center, 1000 N.E. Multnomah Portland OR 97232 (503) 249-3121.**

**Rate is \$94.00 for a standard room or \$104.00 for a premium room. Reservation # 800-996-0510 - ask for the Lewis and Clark rate.**

**Special Awards: Sturdi carrier awarded to highest cat in show by Royal Canin. Also food coupons from Royal Canin and litter coupons for Dr. Elsey's cat litter products in each ring for best cat in championship, kitten and premiership.**

**Cage Size:** Single cage size is 21" x 21" x 21". Double cage size is 45" x 21" x 21". No more than one cat or two kittens may be benched in a single cage. All cages must have curtains covering the back, sides and top in addition to a rug or mat on the floor of the cage. **All Security cages require a double cage space; \$15.00 double cage fee applies.**

**Awards:** Ribbons and rosettes will be awarded for all wins in accordance with CFA Show Rules General Information: This show will be conducted in accordance with current CFA Show Rules. A copy of the CFA Show Rules may be obtained for \$5.00 from CFA, PO Box 1005, Manasquan, NJ 08736. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional awards. Registration numbers must be printed in the catalog. It is the exhibitor's responsibility to check the entry confirmation and notify the entry clerk of any errors before the closing date.

**Check-In and Judging:** Check-in will be from 7:30 to 8:30 a.m. Saturday. Judging will begin promptly at 9 am on Sat. and 8:30 am Sun. Advertised show hours will be from 9 a.m. - 4 p.m. Exhibitors and their cats must stay in the show hall during the advertised show hours, unless they receive permission from show management.

**Show Hall:** This is a non-smoking facility. Handicapped access is available. It is approximately 20 minutes from the Portland International Airport (PDX).

**Supplies and Miscellaneous:** Litter will be provided. Cat food will be provided as donated. Please bring your own food and water dishes, and your own litter pan. People food will be available from the concession stand. No outside food is allowed by this facility.
