FAXED Entries/ONLINE ENTRIES - It is the responsibility of the exhibitor to confirm that FAX/ONLINE entries are received and legible. CFA rules require that your cat's front and back claws be clipped. Our show is held under the auspices of the Cat Fanciers' Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$5.00 from CFA, PO Box 1005, Manasquan, NJ 08736. The club has the right to add judges not named in the show announcement to judge nonchampionship and non-premiership classes. All championship, premiership, and registered kittens will be scored for CFA National and Regional awards.

Litter will be available. Please bring your own litter pan, water bowl and cat food. People food will be available. The club will exercise due care in the sponsorship of the show, but will not be liable for any loss, damage, or injury. Our show hall, Cherry Hill Armory, is not air- conditioned Smoking is not permitted. Directions and hotel information will be sent with the confirmation.
