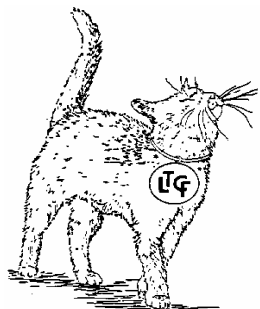

All entries must be submitted on the official CFA entry blank, accompanied by the proper fees. CFA registration numbers must be included for all championship, premiership and AOV classes. Kittens must be four months old by the first day of the show. Make checks payable to **Liberty Trail Cat Fanciers**. A fee of \$40.00 will be charged for any checks returned by the bank for any reason. All checks must be drawn on US banks or paid in US funds.

**Starting Times:** The show hall will be open at 7:30 a.m. All cats must be benched by 8:30 a.m. or they will be marked absent. Judging will begin promptly at 9:00 a.m. on Saturday. All entries must remain in the show hall until 4 p.m. unless permission is received from the show manager.

**NO CAT OR KITTEN MAY LEAVE THE SHOWHALL UNLESS CRATED AND ACCOMPANIED BY OWNER OR AGENT!!**

**FAXED Entries/ONLINE ENTRIES** - It is the responsibility of the exhibitor to confirm that FAX/ONLINE entries are received and legible. **All Entry fees must be paid within 10 days or start of show (whichever's first).** Send Entry clerk an email indicating you sent FAXED/ONLINE entries and they will confirm if it was received via a return email/fax.

**Cages** are approximately 22"x22"x22". All entries should be inoculated against Feline Enteritis, Rhinotracheitis, and Calici Virus and tested for FeLV by a licensed vet. Cats should be free of mites, fleas, and fungus. CFA rules require that your cat's front and back claws be clipped. Our show is held under the auspices of the Cat Fanciers' Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$5.00 from CFA, PO Box 1005, Manasquan, NJ 08736. The club has the right to add judges not named in the show announcement to judge non-championship and non-premiership classes. All championship, premiership, and registered kittens will be scored for CFA National and Regional awards.

**Litter will be available. Please bring your own litter pan, water bowl and cat food.** People food will be available.

The club will exercise due care in the sponsorship of the show, but will not be liable for any loss, damage, or injury. Our show hall, **Cherry Hill Armory**, is not air- conditioned Smoking is not permitted. Directions and hotel information will be sent with the confirmation.
