Benching Info: Check-in between 8:30 and 9:30 AM Saturday.
Judging will begin at 10:00 AM Saturday, 9:00 AM Sunday.
Advertised closing time is 5 PM Saturday, 3 PM Sunday.

This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against Feline Enteritis, Rhinotracheitis, Calicivirus, rabies and tested for FeLV prior to entry. All claws must be clipped, front and back. Cats are not allowed to remain in the show hall overnight. No smoking permitted in benching areas. Litter will be provided, please bring your own litter pans. Cage sizes are 22"x22"x22". Lucky Tom Cat Club will take reasonable care to safeguard the property of exhibitors and vendors. Neither the club, its members nor the St. Louis Marriott West will be liable for any loss or damage. All cats must be removed from the show hall at the close of the show Saturday night. The show hall is handicapped accessible. Food will be available.

CFA Info: All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. show is licensed by The Cat Fanciers Association, Inc. All CFA rules will be strictly enforced.
