ENTRY FEES: Entries are \$47.00 for the first entry, which includes catalog. Additional entries from the same owner are \$40.00. HHP entries limited to 10 entries. A limited number of double cages will be available for \$20.00 and requests will be honored on a first come, first serve basis. Grooming spaces \$35.00 and based only on availability. End of row benching is \$10.00. Sorry, no sales cages available. Entries may be paid using PayPal or check. Substitutions are \$10.00 and returned check fee is \$75.00. Fax/Email entries **MUST** be PAID within 10 DAYS of entry or a \$5 per entry fee will be assessed at check-in. If the show fills, entries not paid will be placed on a waiting list behind those entries already paid in full. PLEASE call or email entry clerk to confirm receipt of faxed and email entries. No substitutions accepted after the closing date. No refunds made once your entry is received. One agent or bench request per exhibitor. Make checks payable to The Mad Catters. The entry clerk will call COLLECT if any questions arise concerning your entry. Phone entries and post dated checks are prohibited. Entries limited to 225.

Closing Date: March 29th, 2010, or when 225 entries are received, whichever comes first. ENTER EARLY!!! We return numerous entries each year because WE ALWAYS FILL EARLY!!!

ATTENTION HHP entries! HHPCC Best Cat rosette and prizes to all finalists to be awarded in each HHP final. The Highest Scoring HHP in Show will be scored and awarded a special prize.

ENTRY INFORMATION: Entries must be submitted on an official CFA entry form, which may be obtained from the CFA at www.cfainc.org. All entries must be signed. CFA registration numbers must be included for all Championship and Premiership classes. All entries should be inoculated against Panleukopenia, Rhinotracheitis and the Calici Viruses, and we recommend that they be tested for FeLV prior to entering the show hall. All cats must be free of mites, fleas, fungus and any contagious illnesses. All claws (front and back) must be clipped prior to benching and no declawed cats will be accepted. All Household Pets over the age of 8 (eight) months must be neutered or spayed. All Championship, Premiership and Registered kittens will be scored for National and Regional awards. All show rules will be strictly enforced. Copies of the show rules are available for \$5 from CFA, 1805 Atlantic Avenue, CN 1005, Manasquan, NJ 08736-1005.

BENCHING: The Showhall opens at 7:30 a.m. on Saturday and all cats must be benched by 8:30 a.m. or they will be marked absent. The show will start promptly at 9:00 a.m. All entries must remain in the show hall until 5:00 p.m. Bring your own litter pans. Club will provide litter. Individual cage size is 22" X 22" X 22".

ACCOMMODATIONS: Our show hotel is the Holiday Inn in the Francis Scott Key Mall, 5400 Holiday Dr., Frederick, MD 21703 (301)694-7500 and well behaved cats are welcome. Show Rate: \$111.
