Payment Info: *Please make checks payable to Mid-Ohio Cat Fanciers.* Post-dated checks will not be accepted. Full payment must accompany all mailed entries. Per Show Rules 6.21, each entry must be accompanied by the stipulated entry fee. All online entries must be paid in full within ten (10) days of receipt or prior to the start of the show, whichever is first (cash, check or money orders accepted only). The use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the form is considered to be your signature. <u>No withdrawing entries once they're entered.</u> There is a \$50 fee for any returned checks. *Payments not received within two weeks after the show date, will incur an additional \$50 late fee.*

Show Hours: Check-in on Saturday will be from 7:30 to 8:30 a.m. The advertised show hours are: Sat. 9-6 and Sun 9-4.

Benching Requests: Every effort will be made to honor your benching requests to the best of our talents; but at least one request per exhibitor is guaranteed. A clerk near their rings is **not** counted as a request. Space provided, handicap requests will be benched at no charge to the exhibitor.

Transportation: Exhibitors will be responsible for their own means of transportation.

Food: Home-style Breakfast and lunch will be cooked and served by the fairgrounds' hospitality volunteers.

Miscellaneous: Show management will take reasonable care of cats and carriers, but will not be responsible for damage or loss. The show hall is a NON-SMOKING facility with heating and air conditioning. Benching cage size is 22x22x22. Litter will be provide, bring your own pans.

Vetting: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a Temporary Registration Number.
