**Entries:** It is the exhibitor's responsibility to confirm all online entries with the Entry Clerk; the club will not be responsible for misdirected entries. Per show rule 11.08 a.; each entry *must* be accompanied by stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to start of show. **Make checks payable to Mo-Kan Cat Club, Inc. or send PayPal send payments to [entryclerk@webfelines.com](mailto:entryclerk@webfelines.com). Single entries with ANY size security cage requires the purchase of an extra ½ cage.** All championship, premiership and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number.  
**Show Hall:** KCI Expo Center, 11728 NW Ambassador Drive Kansas City, MO 64153. Phone: 816-801-8400. The show hall is handicapped accessible, non-smoking and air-conditioned. **Parking is free.**  
**Airport:** Kansas City International Airport (MCI).

**Check in & Show Hours:** Check-in 8:00 – 9:00 am. Judging will begin at 9:00 am. Advertised hours are 9:00 am to 5:00 pm.

**Show Hotel:** No official show hotel though the Holiday Inn is attached to KCI Expo Center. **Holiday Inn KCI Airport**, 11728 NW Ambassador Drive Kansas City, MO 64153. Phone: 816-801-8400. Hotel has an airport shuttle and free transport within 5 miles.

**Cages:** A single cage measures 21" x 21" x 21", a double cage measures 21" x 21" x 42". Bring litter pans and food, litter will be provided.

**Rules:** It is advised that all entries be tested for FELV and be inoculated by a licensed veterinarian against Feline Panleukopenia, Rhinotracheitis, Calici Virus & Rabies before entry. Claws of all feet must be clipped prior to benching. No declawed cats allowed. All cats must be free of fleas, fungus, ear mites, and any contagious illness. Show Management reserves the right to cause the removal of any cat from the show hall if any of the above until a licensed vet can make an examination at the exhibitor's expense. This show will be conducted under current CFA rules; show rules are available for \$7 from CFA, 260 East Main St. Alliance, OH 44601.

**Liability:** Mo-Kan Cat Club will take reasonable care to safeguard property of exhibitors. Neither the club, its members or KCI Expo Center will be liable for loss or damage.
