It is strongly advised that all cats or kittens entered in the show be inoculated by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all cats must be clipped prior to benching. DECLAWED CATS ARE INELIGIBLE FOR ENTRY.
