Cages are approximately 22"x22"x22". All entries should be inoculated against Feline Enteritis, Rhinotracheitis, and Calici Virus and tested for FeLV by a licensed vet. Cats should be free of mites, fleas, and fungus.

CFA rules require your cat's front & back claws be clipped

Our show is held under the auspices of the Cat Fanciers' Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$5.00 from **CFA, 1805 Atlantic Ave., Manasquan, NJ 08736.**

The club has the right to add judges not named in the show announcement to judge non-championship and non-premiership classes

All championship, premiership, and registered kittens will be scored for CFA National and Regional awards.

**Litter will be available. Please bring your own litter pan, water bowl and cat food.**

People food will be available. Cats may not be left in the show hall overnight.

The club will exercise due care in the sponsorship of the show, but will not be liable for any loss, damage, or injury. No watchman will be provided during the hours the show is not open.
