**Show Hall:** The Dulles Expo & Conference Center is located on Rt. 28 at Willard Road in Chantilly, Virginia, 20151. 703-378-0910. The show hall is air conditioned and wheelchair accessible. People food is provided and there is plenty of free parking. This is a non-smoking facility.

**General:** Directions and hotel information will be sent with confirmation. Litter will be provided at the showhall. You should bring litter boxes, food, bowls, and any other supplies. This is a non-vetted show. All cats and kittens present in the show hall should be inoculated against feline enteritis, feline rhinotracheitis, calici viruses, and rabies (required by Virginia state law - bring proof of vaccination), and tested negative for FeLV. Cats must be free of fleas, mites, fungus, and contagious diseases. Cats and exhibitors in violation must leave the show. All entries must have all claws clipped prior to benching. Declawed cats are not eligible for competition. Use of Security cages with an odd number of entries will require the purchase of an extra 1/2 cage. CFA rules will be strictly enforced. All championship, premiership, and kitten entries with registration numbers or temporary registration numbers will be scored for CFA National and Regional points. Owners of novices can contact the entry clerk for a temporary registration number. No refunds for failure to bench. Cages are 22"W x 22"D x 22"H.
