Returned Check Fee \$50 • No Substitution Fees Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first.

Show Hall: Dulles Expo Center, 4320 Chantilly Shopping Center, Chantilly, VA 20153 (Rt. 28 at Willard Road) Ph: 703-378-0910. The show hall is air conditioned and wheelchair accessible. People food is provided and there is plenty of free parking. This is a non-smoking facility.

Check In & Show Hours: Saturday from 7:30 - 9:00 am. Judging will start at 9:30 am both days. Advertised show hours are 9:30 am - 5 pm Saturday; 9:30 am - 4 pm Sunday. No entries, with the exception of kittens, may leave the show hall before the end of the advertised show hours without the permission of the Show Manager.

Entry Info: Entries are accepted now. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING DATE. Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count.

Supplies: Bring your own litter pans. Club will provide litter. Individual cage size is 22" X 22" X 22".

Hotel Info: The Holiday Inn Express (across the parking lot). 4335 Chantilly Shopping Center, Chantilly, VA 20151 PH: 703-815-6060. Special show rate is \$99. The hotel offers a Courtesy shuttle from Dulles Airport. <u>Be warned it fills early.</u> Another option is the Red Roof Plus+ Washington DC/Manassas 10610 Automotive Dr. Manassas, VA 20109 PH: 703-335-9333 which is 10-15 minutes away. Use CFA discount code 526223.

Fly-ins: Dulles International Airport (IAD) is a 15-20 minute drive. Reagan National Airport (DCA) is a 45-60 minute drive. Baltimore Washington International Airport (BWI) is about 1 1/2-2 hours away.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

For Sale Cats & Kittens: Sales cages will be available only if you have an entry in the show. Please keep in mind the show rule which limits two kittens per single cage. No kitten under 4 months of age is permitted in the show hall. Virginia state law requires a rabies certificate for all cats/kittens 4 months of age or older.

Liability: National Capital Cat Show will take reasonable care to safeguard entries and the property of exhibitors. Neither the club, club members or the Dulles Expo Center will be liable for any loss, damage or injury. The sponsoring clubs reserve the right to add or substitute judges not named in show flyer should it become necessary.
