**Final Awards:** Each judge will select 1 overall Best of Breed/Division in their ring (one winner from among the BOB Kittens, BOB Championship cats and BOB Premiership cats). Overall *Best of Breed/Division* winners will receive a beautiful rosette (there will not be a Presentation).

*Best of the Best* will be top 3 Longhair and top 3 Shorthair in Kitten, Championship, and Premiership (18 in all). These 18 cats/kittens will be judged by a special celebrity judge, who will pick 2nd runner up, 1st runner up and *Best of the Best* from these 18 cats.

**Household Pets:** HHPs will be judged in all 10 rings. Top 10 will be awarded in each ring.

**Rescue Adoptable Cats:** There will be an exclusive ring for rescue cats on Saturday; each rescue cat will receive a beautiful rosette.

**Check In:** Saturday 7:00 – 8:30 am, cats not benched by 8:30 am will be marked absent and exhibitor must notify the clerk in each ring that they are present.

**Judging will start promptly at 9:00 am on Saturday & at 8:30 am on Sunday.**

**Advertised Show Hours:** 10:00 am to 5:00 pm on Saturday and 10:00 am to 4:30 pm on Sunday. No cats will be permitted to leave the show hall before the posted show hours without the permission of show management.

**Entry Info:** Entries must be typed or printed clearly on an official CFA entry form. No phone or fax entries will be accepted. It is the exhibitor's responsibility to confirm receipt of all online entries with the Entry Clerk. All entries, except online entries must be accompanied by full entry fee payment. All online entries MUST be paid in full within 10 days of receipt or prior to the start of the show, whichever is first as per CFA Show Rule 11.08a. Make checks payable to **Cat Fanciers' Association** please note National Show on the check. Make PayPal payments to [payonline@cfa.org](mailto:payonline@cfa.org), please note National Show in the message field. PayPal payments must be made **PRIOR** to closing date. By entering, exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. Copies of CFA show rules may be obtained for \$7.00 each from CFA, 260 East Main St. Alliance, OH 44601. \*Use of ANY SIZE security cage will require the purchase of a double (extra ½) cage. The size of a single (1/2 cage) is approximately 22" x 22" x 22". \*\* End of row spaces are extremely limited.

Litter will be provided. Please bring your own food & water bowls, and litter pans.

**Benching:** Cats will be benched by breed unless otherwise requested.

**Ribbons:** The CFA National Show will be using permanent ribbon designations. The traditional cloth ribbons, as well as entry blanks, are available at the Master Clerk's table. All championship, premiership and kitten entries with registration numbers will be scored for CFA National and Regional points.

All claws of all entries must be clipped prior to benching. No declawed entries are permitted. No kittens under 4 months are permitted in the show hall or on the show grounds. No cats or kittens may be confined in carriers. No cats or kittens may be left in the show hall overnight. This is a non-vetted show, it is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry.

**Household Pet Info:** All HHPs 8 months and over MUST BE NEUTERED OR SPAYED. HHP kittens (4 - 7 months) may be unaltered. In accordance with CFA Show Rules declawed cats CANNOT be shown. **Agility:** Entry Fee is \$10 if entered in the show, and additional \$20 if a half cage is needed for Agility cat.

**Fly-In Info:** Indianapolis International Airport (IND) is approximately 20 miles (35 minutes) from the show hall, please book flight accordingly. Sorry, no transportation will be provided.
