Entries: Entries are accepted now. Entry fees include CFA/Regional surcharges. No additional fees for online/faxed entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to New England Meow Outfit; Returned Check Fee \$50. Entries can be paid via PayPal; send to <u>nemocatclub@yahoo.com</u> **PRIOR TO CLOSING**. Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Sales cage must accompany a paid entry. Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage. Benching requests made at the time of entry will be honored when possible.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count. Show rule 2.19E The MISCELLANEOUS (Non-Competitive) CLASS is for any registered cat or registered kitten of a breed not accepted for Provisional Breed competition. Miscellaneous Class entries are examined by judges; however, no awards will be made in this class.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching.Declawed cats are not eligible for competition.

General: Cages are 22"W x 22"H x 22"D. CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. NEMO reserves the right to substitute judges in case of illness or emergency.
