**Entries** properly completed must be submitted by exhibitors in the form of an official CFA entry form or facsimile, or an entry sent online (see link at web site above) following such entry form, with all information except signature typed or hand-printed. The use of the online entry form is interpreted as an official entry in this CFA show, and your email address on the online entry form is considered to be your signature per CFA Show Rule 4.05. If you are faxing or using the online entry form, please confirm receipt. No phone entries accepted. Each entry except faxes or online entries – extra fee only for faxes – *must* be accompanied by the full entry fee. All fax or online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Club shall charge \$25 for entry fee nonpayment beyond the 10-day limit in CFA Show Rule 11.08a. All checks must be paid in U.S. funds. No refunds will be given for failure to bench. Limit one benching / agent request per exhibitor.

Benching. Entry check-in is at 8:30 to 9:30 AM on Saturday.

Judging will begin promptly at 10:00 AM Saturday, 9 AM Sunday. No change of benching assignments shall be made without the permission of the show manager. Benching cages are minimum 22"W by 22"D by 20"H. All benched entries, with the exception of kittens, must remain in the show hall until the advertised closing hour of 5 PM Saturday, 4 PM Sunday.

Chow Hall is heated, handicapped accessible and both hall and School grounds are non-smoking per New Hampshire law. No food or drink is allowed in the benching area (gym) – a cafeteria with seating is within the building. Show management will take all reasonable care to safeguard the personal property of exhibitors. However, neither the club, its members, nor the show hall shall be liable for loss or damage to such property.

**Exhibitor Information.** No litter pans will be provided – we remind exhibitors to bring their own. All Championship, Premiership and registered Kitten entries will be scored for CFA National and Regional awards. All claws of all entries must be clipped prior to benching. No declawed entries are permitted. Cats or kittens should be clean and free of fungus, fleas, ear mites, and any contagious or infectious illness. There will be no veterinarian inspection prior to benching. However, it is strongly advised that all entries be inoculated before entry by a licensed veterinarian against feline enteritis, feline

rhinotracheitis, calici viruses and rabies, and strongly recommended that entries be tested and found negative for FeLV before entry. The State of New Hampshire mandates current rabies inoculation for all cats and health certificates current within 10 days for cats/kittens being sold; it is advisable that you bring your cat's certificate(s). No kitten under the age of 4 months shall be permitted in the show hall. Only benched cats or kittens may be present in the show hall – none may be confined to carriers, either displayed or under cages. All cats or kittens for sale or lease must be benched in the benching area, and must be eligible for CFA registration. The person offering the cat or kitten for sale must have an entry in the show and must ensure an enclosed, secured carrier is used for the transport of the cat being sold. Any sales activity is subject to the approval of the show management. Exhibitors must transport cats into and out of the show hall in an enclosed, secured carrier. No exhibitor may leave cats or kittens in the show hall overnight. First-time exhibitors should contact the show manager for assistance.

how Hotel is the Dover Comfort Inn & Suites, 10 Hotel Drive, Dover NH 03820, phone 603-750-7507. The hotel is 3.5 miles from the show hall and has a complimentary shuttle service to anywhere within 5-10 miles of the hotel. The **show room rates** per night are \$84 for king, \$94 for two queens, \$99 for King Suite, \$104 for Two Queen Suite. Show room rate is being held until January 7, 2011 - call the local number and cite "NH Feline" to obtain show room rate. Note that room rate may increase after January 7. Show room rate includes full breakfast and a waived pet fee. All cats must be confined to cages and/or bathroom. Hotel towels cannot be used for cats. Damages will be charged to the exhibitor; exhibitor must sign a damage waiver with credit card backup at check-in.
