\$52 - 1<sup>st</sup> entry includes catalog.  
Surcharge @ \$2 for CFA/NAR for every entry.  
\$42 - 2<sup>nd</sup> entry (same owner).  
\$32. - 3<sup>rd</sup> entry (same owner).  
\$27. - 4<sup>th</sup> entry & up OR per double cage.  
Limit 1 double cage per cat entered. Owner's cage must pay for double-cage space; no exceptions  
\$108 - 4 kittens (same owner); no substitutions or combining adults with this special rate.  
\$35 - Grooming space.  
\$5 - Substitutions until closing Jan. 11 at NOON.

No single cage if End of Row.  
End Of Row \$20 or free if medically handicapped; must let Jane know by Jan.11 what your needs are in order to get EOR free & so she can bench appropriately (on crutches, bringing own special chair, etc). No benching change w/o mgr's OK.

**BENCHING REQUESTS:** One request per person and not by breed. If you name an AGENT, that is your one request. If more than one person names person X as agent, we are not responsible for who is benched next to whom. As per CFA Show Rules all fees must be paid within (10) days of entering or opening day of show, whichever comes first. You must waive signature if entries sent by FED-EX UPS or certified mail. Confirm receipt of entries with entry clerk. **NO PAY PAL.. Check-In:** 7:00 am-8:00 am Saturday. **Show Hours:** 8:30 am – 4:30 pm Sat., 8:00 am - 3:30 pm Sun. **Other information** - Any cat showing signs of fleas, fungus, ear mites, or kittens for sale without blue slip proof of age WILL be removed from show hall as per Show Rules. NJ law requires RABIES certificate for ALL CATS. All should be inoculated against feline rhinotracheitis, calici viruses and tested negative for FeLV before entry. All claws must be clipped prior to judging. CAGE SIZE approx. 22" x 22" x 22" single, 22" x 44" x 22" double. No litter pans provided, only litter. Bring your own cat water, food and food dishes. Cages must be covered top, sides and bottoms. Cats may not remain in hall after show hours. All entries must remain in hall until closing time unless kitten or HHP or permission from show manager. Management not liable for loss, damage or injury to any cat or person at show, or for articles left behind. Show held under current CFA Show Rules. Copy of those rules available from **CFA, PO Box 1005, Manasquan, NJ 08736** or online at [www.cfa.org](http://www.cfa.org). Entries must be on official CFA style entry blank. Entry clerk will call collect if she has a question. Hall is heated and is fully handicapped accessible - on ground floor. Nearest airport is Newark International. No hotel shuttle service. No outside alcohol allowed; must purchase on site..
