**Starting Times:** The show hall will be open at 8:00 a.m. All cats must be benched by 9:30 a.m. or they will be marked absent. Judging will begin promptly at 10 a.m. on Saturday and Sunday. All entries must remain in the show hall until 4 p.m. unless permission is received from the show manager.

All entries must be submitted on the official CFA entry blank, accompanied by the proper fees. CFA registration numbers must be included for all championship, premiership and AOV classes. Kittens must be four months old by the first day of the show. Make checks payable to **NOVA Cat Fanciers**. A fee of \$30.00 will be charged for any checks returned by the bank for any reason. All checks must be drawn on US banks or paid in US funds. The show hotel is the Holiday Inn, Street Rd, Bensalem, PA phone 215-638-1500 Rate: Mention the show to get the show rate.

**Faxed/Online Entries** – It is the responsibility of the exhibitor to confirm that the fax/online entry was received and legible. All Entry fees must be paid within 10 days of entry or earlier of the start of the show (whichever's first). Send us an email indicating you Faxed/Online entries and we will confirm if it was received via a return email.

Our show is held under the auspices of the Cat Fanciers' Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$5.00 from **CFA, PO Box 1005, Manasquan, NJ 08736**.

The club has the right to add judges not named in the show announcement to judge non-championship and non-premiership

classes. All championship, premiership, and registered kittens will be scored for CFA National and Regional awards.

Cages are approximately 22"x22"x22". All entries should be inoculated against Feline Enteritis, Rhinotracheitis, and Calici Virus and tested negative for FeLV by a licensed vet. Cats should be free of mites, fleas, and fungus. CFA rules require that your cat's front and back claws be clipped

**Litter will be available. Please bring your own litter pan, water bowl and cat food.** People food will be available. Cats may not be left in the show hall overnight.

The club will exercise due care in the sponsorship of the show, but will not be liable for any loss, damage, or injury. **NO CAT MAY LEAVE THE SHOWHALL UNLESS CRATED AND ACCOMPANIED BY OWNER OR AGENT.** Our show hall is air-conditioned. smoking is not permitted. **Directions will be sent with the confirmation.**
