CHECK-IN: Check-in is between 7:30 and 8:30 AM. Judging will begin at 9:00 AM.

**BENCHING:** This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against feline enteritis, rhinotracheitis, calici viruses, rabies and tested for FeLV prior to entry. All claws must be clipped. Kittens under 4 months of age are not permitted in the show hall. No cats or kittens may be confined in carriers either displayed or under cages. Cage size 22x22x22 inches. Please indicate on Entry Form if you have a security cage.

LITTER: Provided. Bring your own litter pans.

**CFA INFO:** All Championship, Premiership and registered kitten entries will be scored for CFA Regional and National Awards. CFA registration numbers must be provided for all Championship, Premiership and AOV Classes. This is a CFA licensed show; and all CFA rules will be strictly enforced.
