# **Entry Info**

All entries must be submitted on an official CFA entry form or photocopy thereof. Entry Clerk will call collect to obtain missing information or to clarify illegible entries. Payment must accompany all mailed entries. Online/fax entries must be confirmed with the Entry Clerk. The Club will not be responsible for faxed entries not received due to communication errors. Per show rules all payments for online/fax entries must be received within 10 days or no later than closing date. All payments must be made in U.S. funds. Checks or money orders should be payable to One Fine Day Cat Club.

**SHOW HALL:** The Lebanon Valley Exposition Center <a href="www.lebexpo.com">www.lebexpo.com</a> 80 Rocherty Rd. Lebanon, PA 17042 Phone 717-273-3670. The hall is air-conditioned, handicap accessible with ample free parking. Smoking permitted in designated areas. Expo Center charges \$15.00 to park RV's over night. People food available.

CHECK-IN: Check-in is between 7:30 and 8:30 AM. Judging will begin at 9:00 AM.

**BENCHING:** This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against feline enteritis, rhinotracheitis, calici viruses, rabies and tested for FeLV prior to entry. All claws must be clipped prior to benching. Kittens under 4 months of age are not permitted in the show hall. No cats or kittens may be confined in carriers either displayed or under cages. Cage size 22" x 22" x 22". Please indicate on Entry Form if you have a security cage (use of ANY SIZE security cage with a single entry will require the purchase of a double cage space).

**LITTER:** Provided. Bring your own litter pans.

**CFA INFO:** All Championship, Premiership and registered kitten entries will be scored for CFA Regional and National Awards. CFA registration numbers must be provided for all Championship, Premiership and AOV Classes. This is a CFA licensed show; and all CFA rules will be strictly enforced.
