ENTRY INFO: All entries must be submitted on an official CFA entry form. Payment must accompany all mailed entries. Online/fax entries must be confirmed with the Entry Clerk. The Club will not be responsible for faxed entries not received due to communication errors. Payment for online/fax entries must be received within 10 days or no later than closing date of July 4th at 6:00 PM EST or when 225 entries have been received. No calls after 9:00 PM EST. All payments must be made in U.S. funds. Checks or money orders should be payable to One Fine Day Cat Club. Sorry, NO PAYPAL.

<u>SHOW HALL</u>: The Lebanon Valley Exposition Center, 80 Rocherty Road, Lebanon, PA, 17042, 717-273-3670. The hall is airconditioned, handicap accessible with ample free parking. Smoking permitted in designated areas. GREAT people food available.

CHECK-IN: Between 7:30 and 8:30 AM. Judging will begin at 9:00 AM.

BENCHING: This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against feline enteritis, rhinotracheitis, caliciviruses, rabies and tested for FeLV prior to entry. All claws must be clipped. Kittens under 4 months of age are not permitted in the show hall. No cats or kittens may be confined in carriers either displayed or under cages. Cage size 22x22x22 inches. Please indicate on Entry Form if you have a security cage.

LITTER: Provided. Bring your own litter pan.

SCORING: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of Novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers, but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will not be included in the count. This is a CFA licensed show; and all CFA rules will be strictly enforced. One Fine Day reserves the right to substitute judges if necessary due to illness or other emergency.
